



## Facility Rental Rules & Regulations – Bayside Sports Fields - Synthetic Turf

The facility rental rules and regulations govern all individuals in/on/around the Bayside Covenant Church (BCC) Bayside Sports Fields located at 7799 Sierra College Blvd., Roseville, CA. Violation of any of these rules and regulations by any person, regardless of whether they are a spectator, coach, participant, official tournament sponsor, may result in a request by the BCC to that participant seeking corrective action as appropriate. Repeated violations may result in greater penalties, up to, and including temporary or full suspension of participant's use of Bayside Sports Fields.

The following conditions of use are applicable **on all parts of the Synthetic Turf Field surfaces** at the Bayside Sports Fields:

1. NO organized use of the BCC synthetic turf field areas without a valid Athletic Facilities/Fields User Agreement from BCC.
2. No food, beverages (except water), gum, and all snacks, or candy, including shelled nuts, such as sunflower seeds or peanuts, is permitted on all synthetic field surfaces. **Exception:** Personal and team water containers.
3. Outside food and beverages are allowed in the perimeter natural grass and stepped-up grass seating areas and the designated picnic/concession area.
4. No tobacco use of any kind on or near the fields and/or the gated complex.
5. No metal cleats on synthetic turf fields and warm-up areas. Turf shoes or molded rubber cleats must be 3/8" or less. Athletic running shoes are recommended for synthetic turf fields. All footwear should be checked and cleaned, as needed, before entering the synthetic turf field areas.
6. No chalk, paint or other field markings, other than those molded into the synthetic turf fields or applied by qualified users with permission from BCC.
7. No use of gas/propane-powered heaters, fires, or grills of any kind.
8. Food concessions sales are prohibited on BCC property unless approved by BCC in advance.
9. All team players, coaches, and spectators are requested to use water for rehydration while on synthetic turf play fields. The use of sports/sugar-based drinks are discouraged on synthetic turf play fields in an effort to prevent spillage and requiring special cleaning efforts by BCC staff.
10. No hitting/kicking fences with soccer balls, any sports equipment, feet, or other objects.
11. No chairs with sharp ends on fields. Only chairs with wide, and/or flat-bottom support are permitted on the perimeter natural grass seating areas and on any synthetic turf warm-up areas.
12. No tents, shade canopies, umbrellas, team benches, team or corner flags with sharp ends on the synthetic field area. Such temporary structures may only be erected on the designated

spectator viewing areas situated on adjoining natural grass turf or hard surfaces, or on the synthetic field areas when the structures have wide and/or flat-bottom support systems.

13. No glass or metal containers of any kind.
14. No bicycles, skates, skateboards, in-line skates, or scooters.
15. No vehicles are permitted on the synthetic field areas (including emergency vehicles).
16. No animals or pets are permitted. **Exception:** Certified Service animals.
17. No spitting on the field(s). Additionally, team coaches and officials are required to notify BCC staff any time there is bodily fluids (i.e. blood, vomit, etc.) identified on the field surface.
18. No alcoholic beverages.
19. No picking or pulling of the turf fibers or infill granules.
20. No digging into synthetic turf with feet, hands, or any other object.
21. No moving portable fencing from their designated places.
22. No climbing or kicking any fences around the perimeter of the synthetic and adjoining turf field areas, including hitting/kicking fences with soccer balls or other sports equipment or objects.
23. Player warm ups or practices on any of the adjoining natural turf areas (especially during rainy conditions) prior to using the synthetic turf field should be minimized due to organic material being transferred onto the synthetic surface and causing increased maintenance to the field.
24. The renting organization is responsible for inspecting the playing field surfaces and all other site amenities prior to the start of play. If a deficiency or vandalism is discovered, the BCC office or field representative must be notified immediately in order to relieve the renting organization of responsibility for the pre-existing conditions. A voice mail message to the BCC Bayside Sports Fields Program Coordinator at (916) \_\_\_\_\_ is sufficient notification.
